AUDITORS' REPORT

To Jesse Helmer, Candidate:

We have audited the Statement of Campaign Income and Expenses and the Calculation of Surplus or Deficit of Jesse Helmer, Candidate, for the campaign period from April 8, 2014 to December 31, 2014, relating to the election held on October 27, 2014.

Candidate's Responsibility for the Financial Statements

Jesse Helmer, Candidate, is responsible for the preparation and fair presentation of these financial statements in accordance with the accounting treatment prescribed by the Municipal Elections Act, 1996.

Auditors' Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

Basis for Qualified Opinion

Due to the nature of the types of transactions inherent in an election campaign, it is impracticable through auditing procedures to determine that the accounting records included all contributions of goods and services, and receipts and disbursement. Accordingly, our verification of these transactions was limited to ensuring that the financial statements reflect the amount recorded in the accounting records of Jesse Helmer, Candidate, in accordance with the accounting procedures established by the Municipal Elections Act, 1996 and we were not able to determine whether any adjustment might be necessary to income and expenses and surplus or deficit.

AUDITORS' REPORT (CONT'D)

Qualified Opinion
